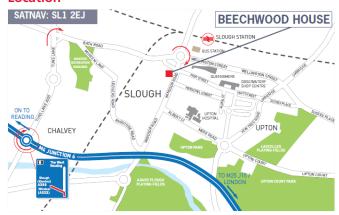

Location



Beechwood House is prominently located on Windsor Road in Slough town centre, close to the junction with High Street. All of the town centre amenities are within easy walking distance, including two shopping centres (The Observatory and Queensmere Centre).

Transport links are excellent with the M4 (Junction 6) being within two miles of the building. Slough railway station offers a fast journey time to Paddington of just 17 minutes and is approximately 5 minutes walk.

The offices are predominantly open plan over a single floor plate, which is accessed via a communal reception area at ground floor level. The basement car park is accessed from the rear of the property via a secure electric roller shutter gate.
